- Analyse social and political reality from a critical perspective
- Understand the relationship between language and social structure
- Understand how power relations shape social discourses

- 3. Subordinate language varieties, stigmatized discourses and social structure
- Diatopic variation, diastratic variation and submission
- Linguistic insecurity
- Acculturation through language and discourse.

## LEARNING ACTIVITIES AND METHODOLOGY

Active learning will be encouraged to ensure that students familiarize themselves with the concepts and tools studied and understand their strengths and limits. In particular, the seminars will be used to critically discuss important readings and a range of examples of discourse. Individual or group projects and various other activities will be used to teach the methodology of discourse analysis.

The general aim of the module is to foster students' capacity for critical thinking.
