- Basics of EU Law

COMPETENCES AND SKILLS THAT WILL BE ACQUIRED AND LEARNING RESULTS.

This seminar (which is taught in English) wants to provide a broad introduction into the policy and Law of the European Union in the domain of environmental protection. It is divided in two parts. In the first one, the seminar explores the basic or constitutional features of this field of EU Law: the historical evolution, the environmental principles; the decision-making process; the legal basis, actors and principles; the connection between the activity of the EU and the regional and global environmental problems, and finally, the implementation and enforcement of EU environmental Law.

In the second part, the seminar: (a) Focuses on the main "horizontal" techniques of environmental protection in EU Law,

such as the environmental impact assessment; environmental liability; IPPC; and access to information, participation in decision-making and access to justice in environmental matters (b) explores a couple of sectors of substantive environmental legislation,

By participating in this seminar the Spanish-speaking students will also reinforce their English communication skills.

LEARNING ACTIVITIES AND METHODOLOGY

- Regular lectures

- In-class discussion of legal materials and ECJ rulings in the field of environmental protection
- Paper writing .
- Individual work by the student (preparation of the materials and in-class discussions).

ASSESSMENT SYSTEM

Regular exams session:

In addition to attending and taking active part in the regular lectures, the students are required to write a short paper on any subject in the field of EU Environmental policy and law, following the formal requirements established by the professor. The subject matter should be precise and detailed, for the paper is thought to help the students deepening their understanding of this key domain of EU Law.

The grade obtained for this paper will amount to 80% of the final grade. The additional 20% will come from the oral interventions of the students when discussing the cases and rulings proposed in the course.

Extra-ordinary session:

End-of-term exam, consisting in a practical case to solve individually: 80% of total mark.

Rest of the mark: permanent evaluation of participation, attitude and oral interventions of the student during de classes (20% of the total grade).

The absence of more than 20% of the classes causes dismissal from the course.
