LEARNING ACTIVITIES AND METHODOLOGY

The continuous assessment system is based on a teaching process orientated towards enabling the student to internalize Mediation and Negotiation techniques, by means of continuous practical role-play activities, putting into practice the theoretical knowledge acquired, thus making easier its understanding and management of its content. The academic activities will be divided in lectures, during which the program of this course will be developed, and they will be held in large group sessions; and practical sessions, principally consisting in the preparation and participation of students in role-plays, to be prepared individually or in groups, by means of which the knowledge and skills acquired during lectures will be put into practice. Also, practical sessions will include presentations, by students, on concrete topics related to the study

program, discussion on working documents, debates and tests or periodical controls on the issues previously handled.

The overall assessment of this course will be made based on the average of partial grades obtained for the following activities:

Option (i), for all students

The final assessment will be based on a final exam, which shall include a series of theoretical questions, as well as the development of a practical case; it will take place at the date officially designated for this purpose.

Option (ii), for students who have succeeded the content control assignments (point A1) Students having succeeded all content control assignments will be able to choose to elaborate a final work instead of a final exam. The final work shall be related to the topics covered by this course; it shall be handed in at the date officially designated for the course final exam.

C. STUDENTS WHO HAVE NOT PASSED THE CONTINUOUS ASSESSMENT PROCESS Students not succeeding in the continuous assessment process will have to sit a final exam amounting for 60% of the overall grade, in the framework of the ordinary exams call.

EXTRAORDINARY CALL D.

Grading of students in the framework of the extraordinary call will take place in accordance with the following rules:

- a. For students who have followed the continuous assessment process, the exam will amount for the same percentage of the overall grade as in the framework of the ordinary call; both the continuous assessment grade and the final exam grade will be taken account in order to award the overall grade of each student.
- b. Students who have followed the continuous assessment process will be entitled to a final exam amounting for a 100% of the overall grade, in the framework of the extraordinary exams call.
- c. Even if students have followed the continuous assessment process, they will be entitled to obtaining an overall grade exclusively based on the final exam grade, in the framework of the extraordinary exams call, in case this is more favorable for them.
