OBJECTIVES

1. Define and relate the concepts, sources, methods and state of the own of Cultural History.
2. Know the main lines of work and image analysis as a form of cultural representation.

DESCRIPTION OF CONTENTS: PROGRAMME

Hence, this course will focus on the historical development of some forms of cultural representation and technologies from a cultural standpoint. LEARNING ACTIVITIES AND METHODOLOGY
