LEARNING ACTIVITIES AND METHODOLOGY

The program of this course will be developed in lectures and they will be held in large group sessions.

Other types of activities will be carried out in small groups. Activities like the resolution of cases studies, based mostly in the Spanish Constitutional Court'cases or the European Human Rights Court' cases, exhibitions of the students, discussions of the work documents... Periodical controls about the subject matter developed in the semester will also be carried out.

The aim of this combination of work's methods is the develope of the capacities and the competences identified between the Bachelor's degree characteristics.
