# DESCRIPTION OF CONTENTS: PROGRAMME

- The biases of the electoral systems; distributive and intraparty elements.
- The territorial effects of electoral systems.
- How is an electoral system reformed? The international and autonomous comparative.
- The effects of the electoral system on attitudinal components, political corruption and public spending.
- The Spanish electoral system and its proposals for change.

### LEARNING ACTIVITIES AND METHODOLOGY

- Presentations in the teacher's class with support of computer and audiovisual media, in which the main concepts of the subject are developed and the bibliography is provided to complement the students' learning.
- Critical reading of texts recommended by the teacher of the subject: Press articles, reports, manuals and / or academic articles, either for further discussion in class, or to expand and consolidate the knowledge of the subject.
- Resolution of practical cases, problems posed by the teacher individually or in groups

- Exhibition and discussion in class, under the teacher's moderation of topics related to the content of the subject, as well as case studies
- Preparation of papers and reports individually or in groups
