LEARNING ACTIVITIES AND METHODOLOGY

2. Practical sessions in which specific activities are developed through which a practical vision of the content of the topics will be offered. These activities will be duly announced in the Global or Virtual Classroom.

Each of these sessions will take place according to the schedule approved by the CUGC.

The tutorials will be held at the time and under the conditions determined by the teacher in the Global or Virtual Classroom.
