OBJECTIVES

LEARNING ACTIVITIES AND METHODOLOGY

* Teaching Methods:

Classroom lectures and practical sessions consisting of exercises and activities proposed by the lecture and carried out by the student, as well as listening and conversation sessions.

Spanish handbook suggested by the lecture in the beginning of the course according to the level of the students. Lecture notes provided by the lecturer in class together with exercises and suggested activities (listening, conversation, etc).
