## OBJECTIVES

Understanding the inherent mechanisms of the massive processes of communication and civil participation in the web and other multimedia devices.

Gaining a broader knowledge of the latest community's information needs and participation in the media.

Ability to analyze from a theoretical standpoint the following elements: the process of formation and the sphere of action of social networks and their environment, the change produced from traditional media models (based on one-way communication) to the new communication paradigm (based on feedback and two-way interaction with the audience), the limits and determining factors that affect audience feedback, and the persistence of situations of communication and information asymmetry.

## LEARNING ACTIVITIES AND METHODOLOGY

This course will consist of a combination of theory seminars (3ECTS) and hands-on projects (3ECTS) in which the students will be able to put in practice the conceptual base learned in the theory seminars. The students will be required to use bibliography dynamically and to observe attentively the environmental elements susceptible to be categorized in accordance with the concepts learned. Along the semester, the students will elaborate short documented essays in which they will be expected to apply these notions and theoretical framework to real cases of communication and participation in the digital media.

The hands-on projects will be supplemented with in-class analysis and debate on several experiences and platforms for citizen participation in the web, with special attention to their interaction with professional journalistic procedures or formats, and with the analysis of research on new tendencies. All these activities could be in the classroom or online. There will be group tutorials after the essays corrections.

## ASSESSMENT SYSTEM

You can opt for the continuous evaluation of the students who attend at least 80% of the practical and theoretical classes both face-to-face and online. To be able to make means in the ordinary call you must have passed the continuous evaluation with a minimum of 5 and the theoretical test with another minimum of 5.

The theoretical part of continuous assessment is made up of a theoretical test.

In the practices analyzes, tests and other exercises are carried out and the continuous evaluation includes the note of some of them and / or of a work and / or exhibition that is carried out in the master classes. In controlled student various grades throughout the semester: one or two essays and participation in activities such as forums (up to 50%), presentation of a group work (20%), final test / exam (30%).

Those who have a suspension or have not followed the continuous evaluation will apply the current exam regulations.

Documentation is an initial and basic phase in the exercise of Journalism and academic research. When we cite sources and acknowledge other authorities, we are demonstrating our commitment to documentaries and, furthermore, we acknowledge and appreciate the work of others who have shared their knowledge with us. The copying of texts without citing sources as well as the literal transcription of paragraphs without opening or closing them with quotation marks has very serious consequences in the exercise of the profession and this subject can be seriously penalized by the teacher of the group and may suppose the non passing continuous assessment.
