## METHODOLOGY OF WORK.

Objective: To report or other document of professional quality, a maximum of 35 pages, in which the student must solve a problem individually assigned to the direction of the Master. This work is done under the supervision of a guardian appointed by the management of the Master and is subsequently defended before a Jury . Program:

- 1) Explanation of TFM content, methodology, stages of development and evaluation criteria and procedure.
- 2) Allocation of work items to each student.
- 3) Appointment of guardians.
- 4) Performance of Work.
- 5) Evaluation.

## TEACHING METHODOLOGY
