REQUIREMENTS (SUBJECTS THAT ARE ASSUMED TO BE KNOWN)

Students must have completed all mandatory and optional subjects belonging to the LLM in EU Law which have been taught at the campus of the UC3M, and the internship.

OBJECTIVES

Being able to ground and develop reasoning on legal topics, often into an academic context.

Students must be in condition to apply their knowledge and resolution skills on new issues offently arising in less familiar atmosphere, involving wider and multidisciplinary fields.

Students must as well be able to report their conclusions to a specialized and/or a non specialized audience clearly.

Being conscious of growing importance of the EU Law in advocacy and full capacity of implementation of its principles and tools.

Assessing the importance of the Law in order to achieve market efficiency and macroeconomic stability.

Dominating new communication technologies and sources of information on EU law.

Ability to communicate properly in English and Spanish, and to persuade in performing legal reasoning.

Knowledge and ability to use EU substantive and procedural law in legal advisory or trial activity before the national and European courts.

Ability to understand and communicate the way market subjects act and react to supranational regulation.

Knowing the proper techniques to aproach and build trustable relationship with national and international institutions as well as individuals entrusted with the power to supervise the implementation of EU Law.

Dominance of principles regarding State liability for infringement of EU law.

Assessing the efficiency of different regulations of contractis in EU member countries, in civil law, labor and commercial law.

Ability to solve practical cases of great complexity in EU Law.

Achieving assessment of national practices aimed at impeding at national level the implementeation of EU Law.

Knowledge of the areas and cases where principle of supremacy applies.

GOALS

During internship period, student's skills will be tested on ground, under the tutorship of selected professionals, in a fully international and high demanding context.

In particular:

- 1. Students will get skills for the analysis of an international legal issue:
- 2. students will be involved in working teams specialized in both national and international fields;
- 3. to tackle the knowledge being capable of discerning between relevant and secondary features;
- 4. outstanding skills to write a paper containing legal analyses and providing a solution to a case;
- 5. Ability to solve cases involving profesional ethics especially regarding conflicts of interest.

DESCRIPTION OF CONTENTS: PROGRAMME

Students must write a legal report of Due Diligence or a case grounded on real facts. The work will be developed on a chronological schedule, reporting periodically to the tutor in charge of the supervisión. A final oral discussion will take place before an appropriate Board, during a public session.

LEARNING ACTIVITIES AND METHODOLOGY

ACTIVITIES

The tutor of the Due Diligence will be responsible for the whole development of the working activities of the students.

ASSESSMENT SYSTEM

Ordinary session:

- The actitude of the student during the process of drafting its TFM, that will always be based on a practical issue of the application of the Law of the Union, both on a sectorial basis or cross-sectorial basis, specially the analitical capabilities and the technical accuracy, and the personal dedication, that will be evaluated by the Tutor, will be the object of an ad-hoc monitoring by the supervisor/tutor of the TFM. In the event that the student supervised does not efficiently comply with these standards of quality towards its TFM, the supervisor will draft a non-compulsory report so as to be considered by the TFM tribunal. (This will amount to a 40% of the total mark)
- The content of the practical case, the ability to discuss (oral and writing) during the final exam, as well as the ability to answer properly to the questions proposed by the Examination Board will amount to the 60% of the final mark,

Extraordinary session:

- The evaluation of the students will take place under the same conditions as in the ordinary session.

The University uses the Turnitin Feedback Studio program within the SIGMA for the delivery of student work. This program compares the originality of the work delivered by each student with millions of electronic resources and detects those parts of the text that are copied and pasted. If the student has correctly made the appointment and the bibliographic reference of the documents he uses as a source, Turnitin will not mark it as plagiarism.
