**LEARNING ACTIVITIES AND METHODOLOGY****A) TRAINING ACTIVITIES**

The continuous assessment system is based on a practice-oriented teaching that aims to reinforce the learning of the theory through direct experience in cases that should facilitate the understanding and management of its content.

**B) METHODOLOGY TO BE USED**

Lectures in class by the teacher with the support of computer and audiovisual media, in which the main concepts of the subject are developed that will serve as a conceptual and analytical basis in connection with the objectives set and with the documentation provided for the study and the bibliography is provided to complement student learning.

Critical reading of texts recommended by the professor of the subject: Press articles, reports, manual

resolutions and / or academic articles,  
either for later discussion in class, or to broaden and consolidate the knowledge of the subject.

Presentation and discussion in class, under the moderation of the teacher, of topics related to the content of the subject, as well as proposed practical cases

Group or individual work

. The case studies that arise in the theoretical-practical session may be developed by the students in groups or individually. In general, students must upload the cases worked and analyzed to the Global Classroom within the period indicated by the teacher.

. Students must actively participate in the theoretical-practical sessions proposed by the professor.

### C) TUTORIAL REGIME

The tutoring schedules will be published in the global classroom. Likewise, students may obtain personal or group tutorials with prior email.

## ASSESSMENT SYSTEM

**% of continuous assessment (assignments, laboratory, practicals...):** 50

The global evaluation of the subject in the ordinary call will be carried out based on the weighting of the marks obtained in the continuous evaluation activities, which is equivalent to 50% of the final grade. The final exam grade equals the remaining 50%.

The ordinary evaluation system of the subject combines the following activities and percentages:

(i) Final Test. There will be an individual test or final test of knowledge, related to the main concepts developed during the sessions. The weight of this test will comprise 50% of the overall grade

(ii) Continuous evaluation: in this evaluation, various actions will be weighted, such as participation and class attendance, contributions to the resolution of practical exercises, search for different activities and exposition and defense of them, reading of the bibliography and notes obtained in the control tests carried out to check the level of knowledge on the subjects exposed.

In any case, the teacher will publish in the AULA GLOBAL in the first classes the classification criteria of the ordinary evaluation

The attendance of the student is considered essential to access and understand the knowledge and experiences transmitted by the different professors who participate in the master who have an important professional and academic career in the subject developed.

Activities not carried out during the continuous evaluation will be rated with a 0.

Extraordinary evaluation:

In the extraordinary evaluation there will be a final exam that may contain the resolution of a practical case. This exam will be weighted 100% of the final grade. If the student has a continuous assessment grade, it will count 40% and the final exam 60% if it is more favorable.

Students who do not take the final exam, either in the ordinary or extraordinary call, will appear as not presented.
