LEARNING ACTIVITIES AND METHODOLOGY

- Class participation: Each student is expected to attend class, and significantly contribute to the seminar discussion each week. Participation in class discussion (oral or written) is an essential part of the class.

- News Workshop: Each week, a group of students (3-5 members), will present a news report related to the topics explained during the theoretical sessions. This report will consist in a short written report and a 15 min presentation during seminar sessions. For this purpose the report should be argumentative (make a point) and should answer the following questions:

- Brief summary of the news
- Why do you think is the news related to the topic
- What is the main subject of the highlight
- Who is involved in the issue
- Identify and define main political actors
- Principal actors¿ statements/positions
- 2-3 final conclusions
- Sources used
- Prepare one question to be discussed by his/her classmates in class.

Experiential activity:

In collaboration with the subject Introduction to Economics: Visit to the plenary budget session/ parliamentary control session presenting a final reflection on what they have seen.

Competences that the student will acquire with this experiential session: analytical thinking skills, public speaking, reflection on the political culture of the country, cultural immersion.
