**ASSESSMENT SYSTEM**

The evaluation system of the subject is adapted in the academic year to the following guidelines:

Continuous evaluation: Each teacher will value, on his part, the active participation and knowledge of the student through the means specified (mandatory exam in each part, evaluation of individual work, class participation, etc.) obtaining a grade from 0 to 10. The average of parts I, II and III will constitute the continuous evaluation of the subject with 100% of the total value of the qualification of the subject

in the first call.
