REQUIREMENTS (SUBJECTS THAT ARE ASSUMED TO BE KNOWN)

Given the open configuration of this Master on Criminal Justice, beyond the general requirements for application, and admission in the Master, the student does not require any other specific requirement to take this course. However, it is recommended to have completed the degree in the subjects' 'Criminal Law' and 'Criminal Procedural Law'.

The subject 'Criminal liability of legal persons' is a compulsory subject, which content is mixed because it involves a criminal section and proceedings (or procedural) section. The course has 3 ECTS.

OBJECTIVES

In general at the end of the course the student will be able to:

- Make complex arguments regarding the imputation of criminal liability of a legal person, the selection and determination of the appropriate sentence.
- Set the foundation for a corporate compliance model aimed at the prevention of crimes that can be attributed to a corporation.
- Play the roles of prosecution and defense regarding a procedural taxable legal person.

Acquire among others:

- Training to formulate arguments of charge or discharge in respect of the liability of a legal person for failure or avoidance of crime prevention.
- Knowledge on what penalties and ancillary measures should be applied to a collective entity in response to the different variables under the Criminal Code.
- Being able to play the roles of the criminal proceedings themselves with the specific features of the taxpayer corporation.
- General knowledge of different systems of criminal liability of legal persons in the European and international level, and with transnational implications that can have criminal proceedings against legal persons.
- Understanding the structure and contents to be included in corporate compliance program.
- Express and draft charge or discharge allegations regarding liability for omission of the compliance officer or other persons who perform guarantor within the legal person
