Summary of course content:

The optional subject the liability of directors in capital companies develops one of the key issues and most current commercial companies. This is a classic subject in company law, always topical because it raises very vivid conflicts, both internally (company-partnersmanagers), and externally (company-managers-creditors), which was the subject of a major reform in 2003. at the international level, following some serious business crisis, there have been significant reforms in some of the most important national legal systems, as well as the emergence of regulations or proposed regulations internationally (International Accounting standards, Winter Report and the Communication from the European Commission on the modernization of company law and enhancement of corporate governance in the European Union. a plan to move). In Spain, as stated, matter was reformed almost entirely with the socalled Transparency Law (L. 26/2003, of July 17, BOE, July 18, 2003), which incorporated our right, among others things, specific treatment on the subject of listed companies. Recently the corporate legal matters has been consolidated into a single provision, the revised text of the Capital Companies Act 2010. The fundamental precepts of our study we have them in Articles 225 to 232, relating to the duties of directors, and articles 236 to 241 bis, on the liability of directors. Many of these rules have been amended by the recent Law 31/2014, amending the LSC for improving corporate governance. To this must be added the system of liability of directors established by the Bankruptcy Law 22/2003, which has also undergone reforms in recent years: Law 38/2011 (BOE, 11.10.2011), especially Articles 172 and 172 Bis; RDL 4/2014 and Law 17/2014, also the arts. 172 and 172a.
